EXHIBIT C – Customer Layaway Agreement Terms and Conditions

- 1. Exhibit C's Layaway program is offered in store and only on items above a retail price of \$150.00, before tax.
- 2. Unless prohibited by law, this layaway is not subject to cancellation and all amounts paid are nonrefundable if you fail to complete all payments in a timely manner as set out below. No partial pick-up or partial cancellations are permitted.
- 3. Exhibit C will designate a payment amount and payment schedule below. Any single layaway payment that is more than 30 days past due will allow a complete cancellation by Exhibit C.
- 4. An initial payment or down payment of 25% of the total balance due is required to establish the layaway payment plan on the selected item(s).
- 5. The total layaway period will be three (3) months or ninety (90) days in duration, starting from the date the initial payment is made.
- 6. The payment schedule will be as follows:

- 9. The person initiating the layaway must be the same person finalizing the layaway. A picture ID is required for all pickups and refunds.
- 10. A new layaway cannot be created if any payments on your other layaways are delinquent.
- 11. Price adjustments will not be made after a layaway has been put in place.
- 12. By providing customer contact information, you expressly agree that Exhibit C may use those methods to contact you concerning your layaway purchase.
- 13. Unless full payment is made according to the above dates and timelines, merchandise will be returned to stock.
- 14. I UNDERSTAND THAT IF I DO NOT COMPLETE ALL LAYAWAY PAYMENTS, MY LAYAWAY WILL BE CANCELLED, THE ITEMS WILL BE RETURNED TO STOCK, AND I WILL FORFEIT ALL PREVIOUSLY MADE PAYMENTS AS AN ACCOMMODATION FOR THE REMOVAL OF THESE ITEMS FROM OUR SALES FLOOR, LOST SALES OPPORTUNITIES AS A RESULT OF THAT REMOVAL FROM THE SALES FLOOR, AND THE COSTS OF RESTOCKING AND REMARKETING THE ITEM.
